
According to the new law concerning "Individual Number" to be put in effective Jan 1, 2016, each customer is newly requested to inform his/her Individual Number to money transfer business entities including our company at the time of applying money transfer transaction by filling the Declaration of Individual Number. The relevant law is "Law on Tax Report with regards External Money Transfer - In Japanese text *Naikokuzei no tekiseina kazei no kakuho wo hakarutameno kokugaisoukintou ni kakawaru chousho no teishutsutou ni kansuru houritsu* ("内国税の適正な課税の確保を図るための国外送金等に係る調書の提出等に関する法律"). According to this provision, customers are required to take following procedures:


