**Agreement by user**

The user shall agree to the following terms and policy.

- ◆ The maximum amount of any foreign remittance transaction is 1 million yen, including the fee. Further, additional restrictions may be set by the Company, the Government of destination country and/or the financial institutions involved, according to the cumulative number of the user's transactions and/or the cumulative amount.
- ◆ When the Company receives money for a foreign remittance from the user, it will provide him/her with a receipt by an electronic means. He/She shall consent in advance to accept a receipt by electronic means in lieu of a printed receipt unless he/she specifically requests for a printed receipt.
- ◆ When the user requests a foreign remittance, he/she shall declare that it does not fall under the transactions of economic sanctions (e.g., Iran/North Korea/Russia related sanctions) pursuant to the "Foreign Exchange and Foreign Trade Act" and clarify the purpose of the foreign remittance. If the purpose is import settlement or intermediary trade settlement etc., he/she shall declare the item of goods, the origin (country), the shipping area (city), and the destination (country in the case of an intermediary trade). If the purpose is service providing settlement etc., he/she shall declare about the contents of the service.
- ◆ The Company may contact the user to verify the content or legality of this application. In this case, the Company will process the foreign remittance only after the verification.

**同意事項**

本サービスの利用者は、下記の各規約に同意します。

- ◆ 外国送金取引の上限金額は一回当たり100万円(手数料等を含む)であること。また当社の規定或いは送金相手国や当社提携先により、取引の累計回数及び累計金額に応じ、別途制限が設定される場合があることについて承諾します。
- ◆ 当社は、本サービス利用者から外国送金依頼の為の金銭を受領した場合、当該利用者に対して、電子的方法により受取証書を提供します。利用者は、受取証書記載事項を記載した書面の交付を受けることに代えて、電子的方法により提供を受けることにつき、特に書面の交付を依頼する旨を表明した場合を除き、あらかじめ承諾します。
- ◆ 外国送金を依頼する際には、「外国為替及び外国貿易法」に基づく経済制裁対象取引(イラン・北朝鮮・ロシア関連取引等)における規制取引に該当しないことを表明し、送金目的を申告します。送金目的が輸入代金、仲介貿易代金等の場合は、商品の品目、原産地(国名)、船積地域(都市名)、仕向地(仲介貿易の場合は国名)を、役務取引の場合はその内容をあわせて申告することに同意します。
- ◆ 当社が本申込書の内容または適法性の確認のために、お客様に連絡させていただくことがあること。この場合、当社は内容確認後に送金を実行することにつき同意します。

**Protect Yourself from Fraud:**

Only use Kyodai Remittance to send money to friends and family. Never send money to someone you have not met in person.  
Do not transfer money to anyone for an emergency situation you haven't confirmed, for an online purchase, for a credit card or loan fee, to claim lottery or prize winning, for anti-virus protection, for a deposit or payment on a rental property, for a job opportunity, for a charity donation, to pay taxes, or to resolve an immigration matter.
